Dear Hudson YMCA, Preschool Families,

Welcome to the Hudson YMCA Preschool Child Care Program. Thank you for choosing YMCA programs to fulfill your preschool needs. It is our goal to provide a safe, fun, educational and enjoyable environment for your child to learn and grow physically, mentally, and emotionally. I look forward to getting to know you and your child better over the course of the school year.

To ensure a smooth transition into the new school year, I want to provide some general and important information about our program. If you need to contact our staff or leave a message for the program. Please call the Hudson YMCA Preschool Classroom 651-724-9293. In addition to your child's completed YMCA registration form, our program is licensed through the State of Wisconsin. To meet and fulfill licensing rules and regulations, we are required to have the following forms in your child's file at Preschool: (1) Complete Immunization Record (2) Health History and Emergency Plan (3) Child Care Enrollment (4) Child Health Report (5) Preschool Developmental History (6) Transportation Form (if applicable). The Immunization Record can either be printed out from a hospital/clinic or you may fill in the dates on the sheet provided.

<u>day preschool/locations/hudson wi/</u>. These forms are in time sensitive and are due back to the program by open house August 29<sup>th</sup>. Failure to turn in the appropriate paperwork could result in your child being suspended from the program. Furthermore, if your child requires medication to be dispensed during the program hours, State of Wisconsin Authorization to Administer Medication Form is required before any staff member can administer. All medication is required to be in the original container and can be kept on-site at program. (If your child is using transportation you will need to fill out the Transportation form.

Our YPreschool program is located inside of the Hudson YMCA. You will use the Eastside door right next to the playground to enter to pick up and drop of your child daily. Please make sure to bring your Photo ID or anyone picking up as we will be checking them daily. Parents are legally required to sign their child into and out of the program each day in the classroom. In addition, parents or authorized individuals must accompany their child into the program and only those authorized persons over the age of 18 are allowed to drop-off or pick-up children from the program.
